West Highlands Community Updates

Amenity Package Updates:

- Pool Construction: Brock Built is continuing to wait on the city to approve the permits to commence pool construction. Since our March update, Brock Built has re-submitted all original paperwork electronically as required by the city to process permitting during the city's work-from-home response to the pandemic. Until the city approves permits, no further construction can occur. As soon as permitting is approved, we will share this news with the community.
- Dog Park Construction on the WH dog park is almost completed. If you have
 not visited this part of the community please check it out at the corner of
 Sanford and Drew. According to the current plans, water will be available,
 shading, benches, dispensers for dog waste bags, trash cans, as well as
 signage. One fenced area will be designated for smaller dogs and one for
 larger dogs. A list of rules for the dog park will be posted on our website and
 on signage near the park.
- Heman E. Perry Park Improvements The park is scheduled to undergo significant improvements starting in late fall. We are waiting for Atlanta Housing (AH) to release funds to start the common area repairs before transferring this land to the HOA. This is a big undertaking and will have a lot of common area re-work including replacing the playground equipment. We hope to hear from AH soon on these developments.




West Highlands Community Updates

- Landscaping The HOA board has recently consolidated landscaping responsibilities with a sole company to service all maintenance common areas of West Highlands. We welcome GNR Landscaping and we hope you have noticed the improvement in some of our common areas.
- Rockdale Park The City of Atlanta and West Highlands is continuing its privatepublic partnership, "Friends of Rockdale Park". Plans are to clear out the over brush in the park and create a clear path from the Proctor Greenway Trail to Argule Park. Atlanta Housing (AH) will fund the clearing of the retention pond off of Argule Lane.
- **Security** Changes have been made to ProTect security shifts for the summer to cover more of the hours when our neighborhood has been experiencing additional criminal activity. The hours are posted below. Please call 470-825-1460 during these hours to speak with a security officer.

• Home Exterior and Grounds Inspection Process – The HOA board is working with Sentry Management to take over the home exterior and grounds inspections which previously took place twice a year. As West Highlands has grown, this task has become too unwieldy to be performed by volunteers and too difficult to maintain a level of consistency in reviewing the entire neighborhood. This should allow for a more consistent review process across all homes. Please be on the lookout for details from Sentry Management on this new process in the near future.



West Highlands News, Activities and Events

- Food Trucks: The HOA Social Committee has have received enthusiastic response regarding the various food trucks visiting WH in the last two months. The Social Committee will continue to schedule a variety of food trucks as long as there is continued interest. They have been experimenting with days/time and food preferences trying to accommodate a broad range of preferences. Thanks to Wandie Bethune and the Social Committee.
- New Homeowner Orientation The Social Committee had planned to conduct 2-3 events each year to welcome our new homeowners to the West Highlands Community. They conducted their first event in Feb.9. They will reinstate these events once it is safe to gather in larger groups and are discussing how to communicate important information for new neighbors, including potential virtual meetings.
- Updated Parking Policy The primary purpose of these updates was to add language for policies on new phases of the community that have nearly completed construction. Please refer to the <u>West Highlands website</u> for updates and to familiarize yourself on our Parking Policy.
- Westside Quarry Park We are eager for the Park to be opened to the public. The first phase of the park appears to be completed and we are told that we are simply waiting for the Mayor to agree to open. Once the Mayor announces the opening date, we are hoping to arrange for a private tour of the park for WH residents prior to this. We will send out specific details at a later date.
- HOA Meeting The usual spring-summer HOA meeting was cancelled due to the pandemic. However, Brock Built and the HOA Board are planning how to best manage a virtual HOA meeting on November 14th. The meeting will be conducted via video conferencing. Details along for participating will be shared in advance of the meeting. In addition to sharing the FY21 budget the HOA Board will provide updates from various committees. Brock Built will be expected to provide updates on WH Development.

- With the weather warmer, many residents are taking advantage of enjoying the park. Please remember, to conduct a party, gathering, or meeting of over 6 people requires <u>reservations</u>. Updated rules and regulations for the Park and Common Areas, as well as the reservation form have been posted on <u>West Highlands Website</u>. Please adhere to these to help us all share our amenities and respect our neighbors.
- All modifications to the exterior of your property must be submitted to the ACC for approval before any work begins. If work is started without prior approval, the homeowner risks being cited for a covenant violation and may be required to alter or remove the changes at significant additional cost. Please refer to the <u>West Highlands Website</u> to review the forms/process.
- <u>ATL311.com</u> is a great resource for trash pick up and schedule, scheduling bulk collection, garbage bin replacement and more.
- Staff at Columbia Residential have contacted our HOA
 Board regarding the illegal dumping of trash, furniture, and
 other items into their trash compactors. We wanted to
 remind our homeowners that we may not dump any of our
 trash into the trash compactors operated by Columbia
 Residential, but must dispose of it in our own bins.
