# Amenity Package Update

As included in the AHA letter that was delivered to the community, we expect the land transfer to happen in June 2018. The WH HOA Advisory Board has not received any additional updates from AHA since their letter dated 3/26/2018 and are unable to speculate on if there have been any changes that have not been communicated to us. Should AHA fail to follow through with the land transfer as scheduled, the Board will begin the process of notifying AHA of our intent to refund the homeowners and halt the process for future transfers.

Should this process be set in motion the action will be considered permanent and future efforts to pursue land transfers for the purposes of amenity build-outs in WH will cease. If the land transfer does not happen, HOA dues will be reduced accordingly for 2017 and 2018. The methodology for that reduction as well as the process of refunding or crediting homeowners will be determined as necessary. Several homeowners have submitted questions based on the last announcement.

Q: Since the attachment with specific land approved was not included, is this covering the land for all future amenities (athletic fields, dog park, etc) or just the pool/clubhouse and parks as mentioned?

A: Getting the land for the pool/clubhouse is our priority and if the transfer needs to happen in a phased process we will pursue this transfer first in order to expedite construction. The additional green spaces that were referenced include the letter do include existing green spaces such as Heman E Perry park, as well as the areas under the GA Power easement that are intended to be used for the ball fields, dog park, community garden.

Q: Is there any update on the land for WACS and when will their trailers be moved to facilitate construction?

A: The WH Board has not been directly involved in the negotiations between AHA and WACS, however our understanding is that WACS will be relocating to the former Archer high school on Perry Blvd, beginning in June 2018, for the 2018-2019 an 2019-2020 school years. The location of the new school is slated to be located off of Perry Blvd in the vicinity of Sanford Drive and Lucy Compton Lane. The trailers that are currently located at the future pool site are positioned to not interfere with phase 1 of the amenities should the schools scheduling overlap with potential construction activities.

Q: What is the revised timeline for construction in a best-case scenario with closing actually taking place in June?

A: Our goal is to have the pool open in summer 2019.

Q: Will HOA dues increase in 2019 as the result of the pool being built?

A: It is the HOA's intent to not increase dues for the next few years. That being said, the financial needs of the community are analyzed every year to ensure we can meet our obligations

Q: What happens if we don't get the approval to start construction? Will monies paid in HOA dues for the last two years be refunded?

A: If the land transfer does not occur, homeowners will be refunded for money that was meant for the pool/amenities. There will be reductions in dues for 2017 and 2018 if the amenities package does not go forward.

**Q:** Are there committees for the pool etc. and how can I get involved?

A: There are committees that have met, but things have been on hold as we await acquisition of the land. Committees have been set up to review budgetary issues, regulatory issues and construction issues surrounding the amenities. It is the intent to re-activate these committees once we have dates.
